- **Health and Safety, Benches in the parish**: To be considered at the January meeting.
- Play Area in Apple Tree Close: PJH spoke about the condition of the play area which had been discussed with SHDC. SHDC had asked if the PC wish to take ownership of the play area, but it was noted that this could be a very costly venture. At present there was no serious prospect of SHDC allocating any funds towards the play area unless the PC was able to match the cost. The total cost could be £40,000.

After approval by SHDC the NP would be put to electors in the parish for a referendum to adopt the plan. APH had applied for further grant funding to finance the remaining stages of developing the plan.
